City of Burbank Investment Portfolio Report for September 2018 Dated October 26, 2018

CITY PORTFOLIO OVERVIEW

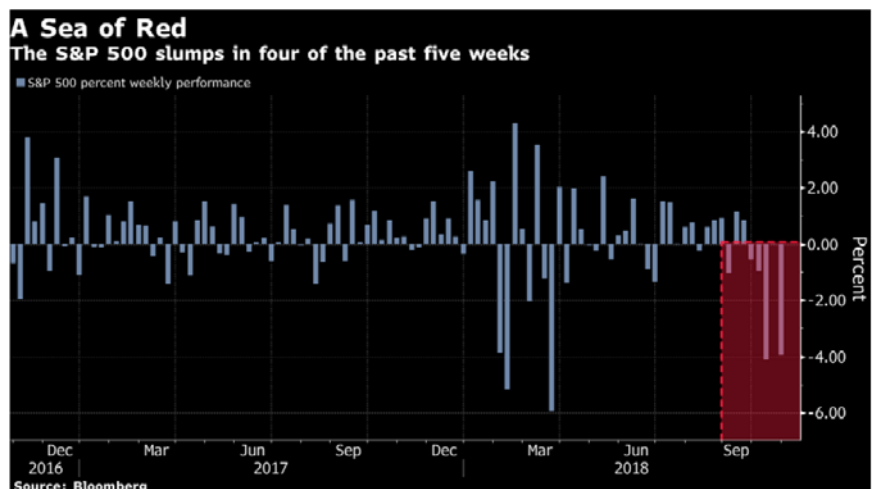
The City must maintain \$92 million in liquidity at all times (maturities within one year plus real estate taxes due from the County in April and December) to meet our projected budgeted expenditures. We currently have \$178 million in liquidity, with \$73 million in our account at the Local Agency Investment Fund (LAIF), \$62 million in investments maturing within a year and \$43 million in real estate taxes due in April and December. Liquidity is being allowed to accumulate in anticipation of cash flow needs over the next few months; this is suppressing upwards yield movement for the portfolio, as maturing amounts are being kept in LAIF to meet liquidity requirements.

The City Investment Pool ended September at \$439 million, up from August's balance of \$432 million. September's market value decreased to 97.91% from August's 98.13%. September's yield came in at 1.94%, with the fiscal year-to-date yield coming in at 1.90%. The weighted average yield of the portfolio at the end of the month is 1.96%. September's monthly yield was boosted by the 3rd quarter allocation from LAIF which included the city's portion of interest on the \$6 billion loan to CalPERS. Interest earnings on the loan are not reported in LAIF's monthly effective yields which are used to calculate the interest accruals each month; LAIF interest is paid quarterly, in the month following the end of the quarter.

MARKET OUTLOOK

Even with GDP growing better than 3.5% in the third quarter, indicating the economy is plugging along, October 26's headlines from Bloomberg include the following, putting a definite damper on the GDP announcement: *S&P 500 falls 10% From All-Time High; 'Sell Everything' as Stocks Dive on Earnings Gloom: Markets Live; Stocks Crater as S&P Joins Nasdaq in Correction: Markets Wrap; and Valuation of S&P is falling more rapidly than during financial crisis.*

Another of October 26's Bloomberg articles, *Stock Market's Strains Send Message The Fed Doesn't Want to Hear* (Elena Popina, Oct 26, 2018), quotes Ilya Feygin, senior strategist at WallachBeth Capital LLC: "This sell-off shows that the markets are pricing in slower growth and more risk." With eight rate hikes in this cycle and more projected to come, it's becoming clear that many investors don't see sufficient strength in market fundamentals to support more hikes. For the bond market, this means a move to safety, driving bond prices higher...and rates lower. 10-year Treasury yields just had their biggest weekly decline in two years.

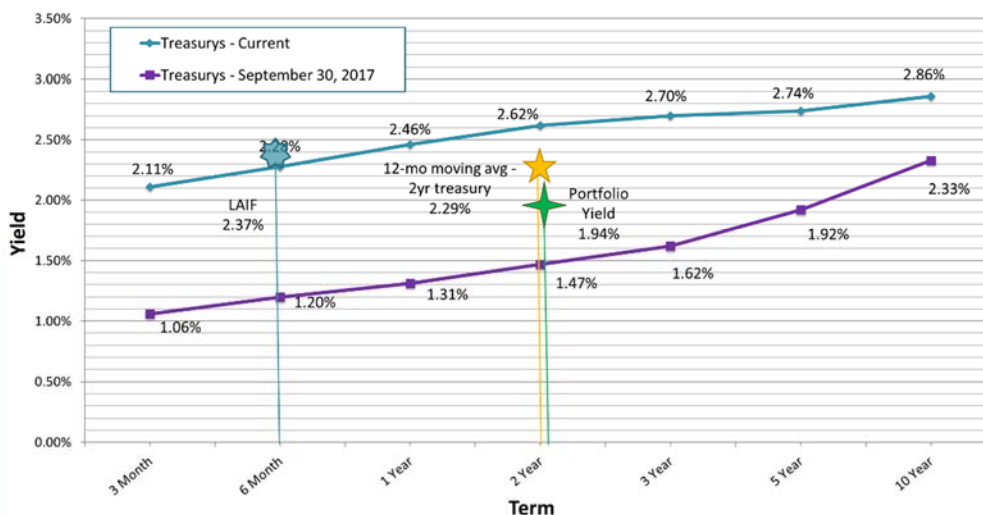

Treasury Rates vs LAIF, Benchmark and Portfolio Returns



The chart to the left shows relevant rates (LAIF, the 12-month moving average of the 2-year treasury, and portfolio current yield) as of September 30, 2018, as well as current treasury yields and those from a year ago.

The portfolio yield is lagging behind the benchmark because of rising interest rates on the short end coupled with the longer duration of our portfolio compared to the benchmark, as well as the recent buildup in liquidity to meet cash flow requirement.

AVERAGE LIFE DISTRIBUTION

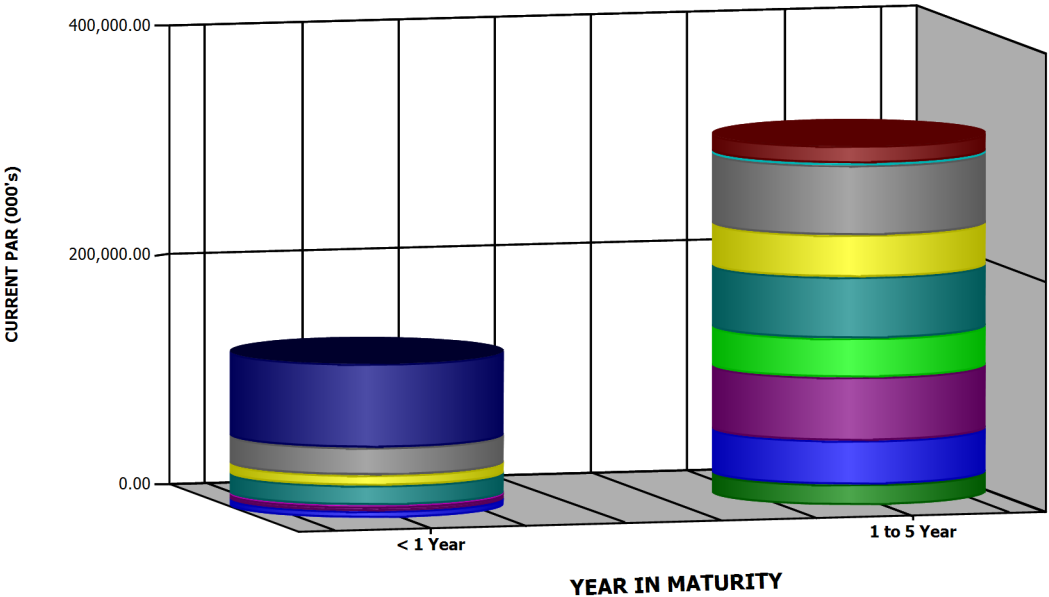

MATURITY DISTRIBUTION

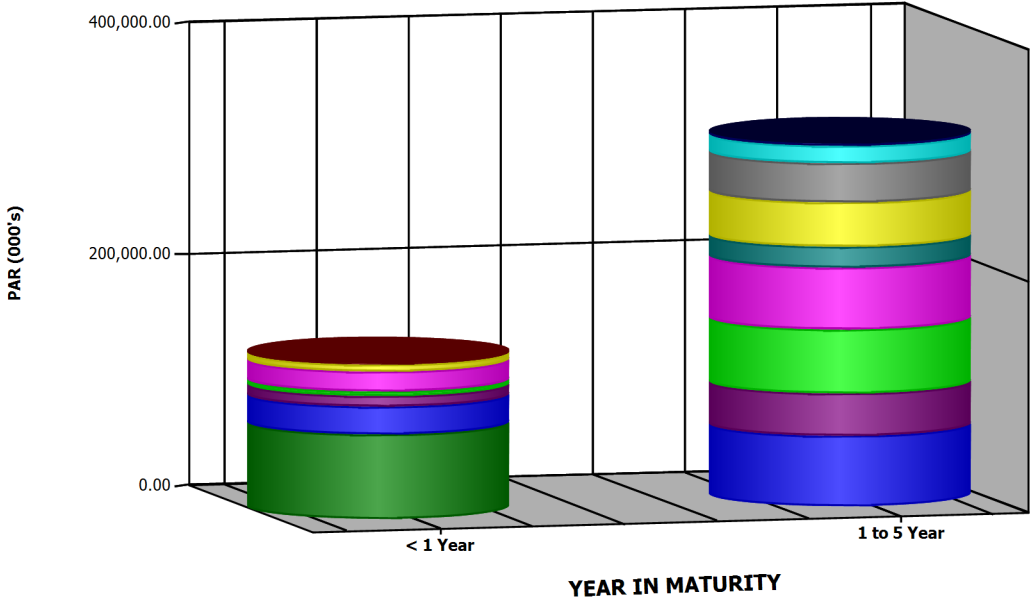
